
In addition, the KYTRIL® 1mg/1mL 4mL MULTI-DOSE VIAL (NDC 0004-0240-09) packaging has changed, including the unit dimensions, case dimensions and weight. Consequently, the case quantity has increased from 132 to 196 units per case, pallet count has decreased from 40 to 24 cases per pallet, and weight changed from 7 lbs. to 10 lbs.
