Roche is pleased to announce a Stocking Program for Tamiflu[®] (oseltamivir phosphate) Capsules (NDC# 0004-0800-85), and Tamiflu[®] for Oral Suspension (NDC# 0004-0810-95) for the upcoming season.

As an important customer in the distribution of Roche products, we are relying on your full support in helping to ensure adequate stocking in all retail pharmacy stores.

Tamiflu[®] Capsules and Tamiflu[®] for Oral Suspension are packaged and distributed as follows:

¹ WAC or Wholesale Acquisition Cost is the list price for wholesalers, distributors and other direct accounts before any rebates, discounts, stocking or distribution allowances, chargebacks, and/or other price concessions that may be offered by Roche. For certain products, one or more forms of price concession, in addition to a prompt pay discount, is available on virtually all sales. Moreover, in the case of some products, these price concessions reduce the net price significantly below WAC.

Introductory Shipment Terms

Roche is providing introductory shipment terms including an additional 60 days dating (2% 90 days, net 91 days) on initial orders for Tamiflu[®] Capsules and Tamiflu[®] for Oral Suspension received by 5 pm EST, September 8, 2006.

Distribution and Stocking Allowances

Roche is offering a one-time, off-invoice discount of 3% of current WAC (Wholesale Acquisition Cost) for Tamiflu® Capsules unit of use blister packs and Tamiflu® for Oral Suspension on initial orders received by 5 pm EST, September 8, 2006 and approved by Roche.

In addition, Roche will pay, in the form of a credit memo, 4% of WAC for each retail pharmacy stocking a minimum of three (3) and maximum of twenty-five (25) unit of use blister packs of Tamiflu® Capsules by October 6, 2006.

For Tamiflu® for Oral Suspension, Roche will pay, in the form of a credit memo, 4% of WAC for each retail pharmacy stocking a minimum a minimum of two (2) bottles and a maximum of four (4) bottles of Tamiflu® for Oral Suspension by October 6, 2006.

In order to obtain your distribution allowance in a timely manner, please follow the instructions below:

- Wholesalers/Warehousing Chains should submit one (1) request for the distribution allowance.
- The request must be accompanied by proof of distribution to pharmacies, which may be in the form of a computer report detailing invoice number, date shipped, and pharmacy name and store location.
- The Tamiflu® distribution allowance rebate request must be submitted by November 6, 2006 to:
