- 3. Product orders must be placed within 6 months of the approval of your request. Order quantity must be within the approved limit(s). If additional product is required, another Request Form must be submitted.
- 4. Commercial product must be purchased from an approved distributor and will be shipped by Genentech. Approved distributors can be found on https://www.gene.com/contact-us/customer-service/ordering.

Important Guidelines:
